#### Watch Out for Scams!

#### **Avoid Phishing and Other Scams**

Criminals are constantly trying to steal consumers personal information using tactics such as fake emails, phone calls, websites, and even text messages. They will try to use a variety of these in order to trick consumers into giving them their bank account number, social security number, and any important information. Their goal is to steal from you. Never click on any links, emails, or respond to any messages that you are not expecting or have not requested.

#### Phishing Attempt at MSB

During this past month, a group of cyber attackers attempted to get information from the customers of many local banks by sending out a mass message to individuals based on their geographic location and the likelihood that they might bank with one of those banks. In this message, they claimed that the customer's account had been charged for a certain amount and then directed them to click on a link if this was not them. Once they had clicked on the link, customers were directed to sign in to their online banking, giving the scammers the information they would need to access customers online accounts. Thankfully, this scam was caught early and the threat was mitigated.

#### Tips to Avoid Being Scammed

Always be cautious and suspicious if you are unexpectedly contacted and asked either for your personal information or told to click on links or messages. Only open emails and respond to messages that are from people that you know or that you are expecting, and even then, you should be cautious if something looks suspicious. If you think an email, message, or link looks legitimate, you should verify it before you click on it or give out any personal information. Always remember, contact your financial institution directly if you have any questions about the legitimacy of a message or a link that seems to have come from them.

Your company may need to file this report if it is a corporation, an LLC or was otherwise created in the United States by filing a document with a secretary of state office or a similar state office.
